## Personal Data Processing Consent

- 1. I explicitly give my voluntarily, informed consent to People Solution Factory EOOD, UIC 204025750 ('The Administrator'), having its seat in Sofia, Bulgaria with registered address at PC 1331, 'Druzhba', 999, 21, 7th Str. (the Company), to process my personal data, including storing it in People Solution Factory EOOD's database, in its capacity of personal data administrator, registered in the Personal data administrators' register with the Commission for Personal Data Protection (CPDP) under № 421286, for the purposes stated in this declaration, namely:
- 1.1. Identifying me as a candidate who is seeking work employment, including passing on my personal data to potential employers;
- 1.2. My work experience and professional qualification evaluation;
- 1.3. Implementation of the requirements stipulated by Employment Promotion Law, Law on The National Archive Fund, etc.
- 1.4. Using my personal data for business purposes, namely:
- (i) to be able to contact me via phone and for corresponding with me regarding the implementation of my obligations stated in my contractual agreement;
- (ii) to be able to negotiate with the person who is offering a job/ employer for signing a contract of employment.
- 2. I am informed that the legal grounds for my personal data processing by the Company is my consent, stated in this declaration, as well as the merits under Article 6, item 1.b "b") of the EU Regulation 2016/679 and the Council of Europe's regulations dated 27<sup>th</sup> of April 2017, regarding the physical persons' personal data processing protection and also regarding the free movement of such data (GDPR)- the processing is necessary in order to be able to implement a contractual agreement, which I am a side of, or to undertake actions per my request as a person whom the data concerns, before signing a contractual agreement.
- 3. I am informed that possible third party persons- receivers, to whom the Company might pass on my personal data are: persons offering work employment, employers, Employment Agency, other state and municipal bodies and I agree my personal data to be passed on to those persons, bodies, and structures.
- 4. I give my explicit consent, my personal data, provided by me, to be stored by the Company as a hard copy and on electronic devices until 5 years also afterwards and the Company has the legal obligation to protect this data according to the rules and regulations of the Bulgarian legislation and the European Union Law.

- 5. Together with the stated above, I am informed that:
- 5.1. I have the right to:
- (i) access my personal data, stored and processed by the Company;
- (ii) to request corrections, changes, and updates of this data;
- (iii) to request restriction for further processing;
- (iv) to ask the Company to erase or block my personal data, in case the processing does not meet the requirements of the Bulgarian legislation and the EU's Law, also to inform the third parties whom the data was revealed to about the blocking and the cancellation, unless it is not possible to do so, or it causes undue effort
- (v) to object to subsequent processing of my personal data, where I have the legal grounds for that;

- 5.3. I can exercise my rights (under it. 5.1) by filing a written application to the administrative address provided in the item above or via the following e-mail address: gdpr@psf.bg
- 6. I have been informed that I have the right to receive the personal data which concerns me and which I have provided to the Company in its capacity of personal data administrator, in a structured, widely used and machine readable format (data that can be easily processed by a computer) and I have the right to transfer this data to another administrator without any objections on the Company's side.
- 7. I provide my consent in my capacity of free willed adult and I am aware that it has been arranged under Article 7 and Article 12- Article 16 of GDPR. I have been informed that I have the right to withdraw my current consent at any time, considering the fact that my personal data processing, or part of it, could continue despite the withdrawal, if the processing is required in order to continue with a contractual agreement with the Company or because of obligations which the Company has to implement by law.
- 8. I have been informed that in case of an argument between myself and the Company whether my personal data is being processed in conformity with the law, I have the right to file a complaint to Commission for Personal Data Protection, in order to protect my personal rights, stated in the text above.
